

RESOLUTION NO. 2017-24

**SCHEDULE OF FINES AND COSTS FOR CRIMINAL, ENVIRONMENTAL AND TRAFFIC VIOLATIONS**

**WHEREAS**, the State of Oklahoma has increased penalty assessment fees required by Title 20 Section 1313.2 of the Oklahoma Statutes; and

**WHEREAS**, the City Council desires to adjust the bond schedule of fines and fees of the Marietta Municipal Court to reflect the increased penalty assessment fees; and

**WHEREAS**, Section 94-36(a) of the City of Marietta Code of Ordinances allows for said schedule to be established by a resolution or motion of the City Council.

**NOW, THEREFORE, BE IT RESOLVED** by the City Council of the City of Marietta:

Pursuant to Section 30-1 of the City of Marietta Code of Ordinances, the schedule of fines and costs, for the bond schedule, which may be paid in lieu of appearance is as follows:

The bond amounts listed below include a \$30 court cost (11 O.S. § 27-126), \$30 assessment fee (20 O.S. § 1313.2 et seq.), \$10 fee for police improvement fund(Sec. 30-2), and \$10 fee for police and court technology fund (Sec. 30-3) unless indicated by an asterisk (\*).
